#### **Personal data that we process**

Groene Hart Camping processes your personal data by using our services and / or because you provide it to us yourself. Below you will find an overview of the personal data that we process:

- First and last name
- Sex
- Address data
- Phone number
- E-mail address
- Bank account number

#### **Special and / or sensitive personal data that we process**

Our website and / or service does not intend to collect data about website visitors under the age of 16. Unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16. #### **For what purpose and on what basis we process personal data**

Groene Hart Camping processes your personal data for the following purposes:

- Calling or e-mailing you if necessary to carry out our services
- Groene Hart Camping also processes personal data if we are legally obliged to do so, such as information we need for our tax return.

#### **Automated decision making**

Groene Hart Camping does not make decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee of Groene Hart Camping).

### **How long do we keep personal data**

Groene Hart Camping only stores your normal personal data. And no longer than is strictly necessary to achieve the purposes for which your data is collected. We use the following retention period for the category of ordinary personal data: 7 years

### **Sharing of personal data with third parties**

Groene Hart Camping provides exclusively to third parties and only if this is necessary for the implementation of our agreement with you or to comply with a legal obligation.

### **Cookies, or similar techniques, that we use**

Groene Hart Camping only uses technical and functional cookies. And analytical cookies that not invade your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferred settings. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via your browser settings.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
