GENERAL TERMS AND CONDITIONS AND HOUSE RULES

APPARTEMENTEN - CAMPING - CAMPERPLAATS - HOOIBERGHUTTEN - ZAALVERHUUR

These general terms and conditions and house rules apply to all guests and visitors of the Groene Hart Camping. These can also be viewed at the sanitary areas, haystack huts, apartments and the website.

- For earlier arrival, € 2.50 per hour will be charged.
- All prices include VAT and are subject to price changes.
- For cancellations within 14 days before arrival, the deposit will not be refunded, but can be offset if you book the same number of nights in the same season.
- The campsite is car-free.
- Charging electric vehicles (except bicycles) is not permitted.
- All areas are non-smoking.
- Leave mattresses in the beds in the haystack huts and apartments.
- We separate the waste, use the containers provided for this purpose.
- Turn the heating/air conditioning down (+/-18 °C) when you are away/leaving.
- Do not place plastic under the tent or awning to preserve the lawn.
- Leave the sanitary facilities and grounds tidy for the next guests.
- You must indicate the number of visitors / additional cars.
- Please take each other into account and prevent nuisance caused by alcohol, music and drugs.
- Your stay on our campsite and the use of the playground is entirely at your own risk.
- For safety reasons, the opening of the tent/awning must be at the front of the camping spot (so not in the direction of the ditch at the back).
- Do not use the trampoline or go-karts before 8:30 am and after 9:30 pm.
- Maximum 2 small people on the trampoline or 1 adult.
- You are not allowed to enter the company buildings without permission.
- In the event of breakage, loss or destruction of our property, this will be charged.
- You are not allowed to go onto the neighbors jetty.
- It is forbidden to dive in the ditch around the campsite and in the Kromme Mijdrecht.
- Cars park in the parking spaces in the parking lot.
- Keep the dogs on a leash.
- Groene Hart Camping can cancel the reservations made if the camping field is in poor condition. The reservation can then be moved in consultation. If this is not possible, amounts already paid will be refunded.
- Groene Hart Camping de Jong accepts no liability for theft or damage to materials and injuries (in any form) to campers, users or third parties who use our site.
- By accepting the terms and conditions you agree to the possible publication of photos and videos taken for promotional purposes.
- Apartments and haystack huts must be provided with garbage removed, refrigerator empty and swept clean.
- Groene Hart Camping reserves the right to access any accommodation in the event of an emergency, maintenance or nuisance (if possible in consultation).
